Special instructions

We have created these operating instructions to help you familiarise yourself quickly and comprehensively with your new appliance.

- This appliance may only be installed once these instructions have been read. The instructions provide important information on safety, use and maintenance!
- Observe all instructions and explanations relating to correct operation and handling. This will ensure that your
 appliance is always ready for use and has a long service life.
- Particular attention should be paid to instructions relating to safety. They help to prevent accidents and protect your appliance against damage.
- These instructions must be made available to the user and retained for future use.

This appliance complies with recognised rules of technology and relevant safety regulations for electrical appliances.

Keep children under 3 years of age away from the appliance if they cannot be supervised at all times. The appliance can be switched on and off by 3- to 7-year-old children if they are supervised or have been instructed in the safe use of the appliance and understand the hazards involved. The prerequisite for this is that the appliance has been installed as described. Children aged 3 to 7 must not insert the plug into the socket or regulate the appliance.

The appliance can be used by children aged 8 years and older and persons with reduced physical, sensory or mental capabilities or a lack of experience and knowledge if they are supervised or instructed concerning use of the appliance in a safe way and understand the hazards involved. Children must not play with the appliance. Cleaning and user maintenance must not be realised by unsupervised children.

- Parts of the appliance can become very hot and cause burns. Special care must be taken when children and vulnerable people are present.
- Do not cover the appliance to avoid overheating it.
- If the appliance is permanently connected, it must be possible to disconnect all poles from the mains connection for an isolating distance of at least 3 mm.
- The voltage specified must correspond to the power supply.
- The appliance must be connected to the protective earth conductor.
- To avoid hazards, the mains power supply cable may only be replaced with an original spare part and by an installation technician authorised by the manufacturer in the event of damage or replacement.

Attach the appliance as described in the "Installation / Assembly" chapter.

Operation

2 Safety

2.1 Intended use

The appliance is used for drying hair and the body.

The appliance is only intended for commercial use in fixed, non-mobile spaces such as swimming pools and changing rooms, and may only be used for drying hair and bodies.

The appliance is intended for use in a domestic environment. The appliance can be operated safely by uninstructed persons. The appliance can also be used in non-domestic environments (e.g. in business and industry), provided it is used in the same way.

Any other use or use beyond this is considered improper. Intended use also includes observing these instructions and instructions for the accessories used.

The manufacturer's liability shall lapse in the event of improper use, improper installation or improper maintenance.

2.2 General safety instructions



WARNING Injury

- Keep children under 3 years of age away from the appliance if they cannot be supervised at all times.
 The appliance can be switched on and off by 3- to 7-year-old children if they are supervised or have been instructed in the safe use of the appliance and understand the hazards involved. The prerequisite for this is that the appliance has been installed as described. Children aged 3 to 7 must not insert the plug into the socket or regulate the appliance.
- The appliance can be used by children aged 8 years and older and persons with reduced physical, sensory or mental capabilities or a lack of experience and knowledge if they are supervised or instructed concerning use of the appliance in a safe way and understand the hazards involved. WARNING Electric shock

Do not insert any objects into the appliance openings.



WARNING Burning

Do not operate the appliance ...

- if the required minimum distances to neighbouring object surfaces or other combustible materials are undershot.
- in rooms where there is a risk of fire or explosion due to chemicals, dust, gases or vapours. Ventilate the room sufficiently before using the appliance.
- in the immediate vicinity of pipes or containers that carry or contain flammable or explosive substances.
- if an appliance component is damaged, the appliance has been dropped or there is a malfunction.



CAUTION Burning

- Do not lean any objects against the appliance.
- Do not place any flammable, combustible or thermal insulating objects or substances on the appliance or in its immediate vicinity.
- Ensure that the air inlet and outlet are not blocked.
- Parts of the appliance can become very hot and cause burns. Special care must be taken when children

Do not cover the appliance to avoid overheating it.

2.3 Test mark



The rating plate is located on the outside on the underside of the plastic hood.



The serial number label is located on the inside of the front of the mounting housing.



3 Appliance description

The height adjuster is set to the desired height by pulling the handle.

The appliance works without contact. If you place your hands or head within the radar's detection range, the appliance's fan is automatically activated.

The appliance dries hair and the body with a pleasantly warm stream of air and switches off automatically when one moves away from the appliance.

4 Operation

Commissioning

- Approaching the hair dryer (hood) to a distance of between 10 and 15 cm activates it without the need to touch it, and the time relay automatically deactivates it after 2.5 minutes (factory setting).
- If you are still standing under the hair dryer after the 2.5 minutes have elapsed, it will run for another 2.5 minutes and only
 switch off automatically when the time has elapsed.
- Approaching sensitivity and the automatic timer can be individually set by the customer (see table).

5 Cleaning, care and maintenance



Damag

Ensure that no moisture or water penetrates into the appliance. The height adjuster should also not come into contact with water. Do not wash walls with sprayed water where Rez height adjusters are fitted.



Damage

Unsuitable cleaning agents can damage the appliance housing.

- ▶ Do not use abrasive or solvent-based cleaning agents.
- ▶ Wipe the appliance housing regularly with a soft, damp cloth.
- ► Clean the air intake area, motor, heater (attention: do not damage the overheating protection thermostat) and outlet grille regularly with a vacuum cleaner and a round brush. (Do this at least four times a year. Important, watch video under 11.1)

6 Troubleshooting

Problem	Cause	Remedy
The appliance does not switch on.	No power is applied.	Check whether a fuse or the RCD has tripped in the domestic installation.
		Check that the mains plug is plugged in correctly.
	Print control defective	Install a new print control – remove the print control from a functioning appliance and install it in the defective appliance to be sure that the print control is the cause.
	Heating defective	Install a new heater – remove the heater from a working appliance and install it in the defective appliance to be sure that the heater is the cause.
Motor does not turn	Motor/heater is defective, or the starting capacitor on the print control is defective.	Install a new motor or replace the print control. Install a new heating system.
Hair dryer functions, but only with cold air	Heating defective	Installing a new heating system

Call a specialist if you are unable to rectify the cause. For better and quicker help, provide the specialist with the model and serial number from the rating plate (Beluga V E 200000 or Beluga V/S F 300000).

7 Safety

The installation, commissioning, maintenance and repair of the appliance may only be realised by a specialised technician.

7.1 General safety instructions

We can only guarantee perfect functionality and operational safety if the original accessories and spare parts intended for the appliance are used.

9 Preparations

9.1 Installation location



Damage

The appliance is intended exclusively for indoor installation. Exposing the appliance to the effects of weather may damage it.



Note


The appliance must be mounted on a wall with a sufficient load-bearing capacity.

► Mount the appliance on a vertical wall only.



10 Installation

Installation instructions, installation conditions, electrical connection:

- This appliance may only be installed if these operating and installation instructions have been read.
- The instructions in this chapter must be observed to avoid injury or damage.

An authorised specialist must be commissioned with the installation to ensure that the appliance is connected in compliance with safety regulations. In rooms with showers and baths, the appliance must not be installed within the safety zones specified in the German VDE association regulations (0.6 m from the edge of the shower or bath and 1.2 m from shower heads). This hair dryer must be installed out of the reach of anyone using a bath or shower.

- Combustible materials must be kept away from the hair dryer.
- Only connect the hair dryer to alternating current via a correctly installed mains supply with a protective earth conductor.


Electrical connection "F", flush-mounted:

The mains supply cable must be connected directly to the terminal provided in the appliance on the installation side.

An all-pole disconnection device must be provided on the installation side from the mains with a contact opening width of at least 3 mm per pole. The mains connection must be protected by a residual current device (PCC)

If the connection cable of this appliance is damaged, it must be replaced with the special type "F" cable, a black spiral cable (H05BQ-F) which can be obtained from the manufacturer and must be changed by a specialist.

- The residual current device (RCD) must comply with EU standards and bear the following symbol
- The mains voltage most correspond to the voltage specification on the rating plate.
- The connected load and the required fuse are indicated on the rating plate.
- The regulations of the responsible electricity company must be observed.
- The connection to the mains must be established so that the internal activation relay interrupts the phase conductor (brown wire to the mains phase conductor, blue wire to the mains neutral conductor and yellow/green wire to the mains protective earth conductor).




10.1 Mounting the wall attachment

The appliance is designed for wall mounting using the dowels and screws provided.


▶ Place the appliance on a soft support so that the surface is not damaged.







Drill the two upper mounting holes \varnothing 10 mm according to the enclosed drilling template.

















Tighten the lower fixing screw.




Hook the power unit onto the pre-mounted height adjuster screws and tighten.




Connect the safety plug (internal cable) on the height adjuster to the power unit.



Lock the plastic hood into the two hinges. Close the plastic hood and screw tightly.



Unscrew the top cover of the height adjuster (loosen on the right and left).



Connect the mains connection cable to the connection terminal in accordance with the labelling.



Note

- ▶ When positioning the wall attachment, note the position and length of the mains connection cable.
- ▶ With regard to the mounting height, orientate yourself on the corresponding reference values in the "Preparations / Reference values for mounting height" chapter.



Damage

If you hit electrical cables while drilling, the fuse will blow and the cable will be damaged. If you hit pipework while drilling, there is a risk of water damage.

▶ Ensure that you do not damage any electrical cables or pipes when drilling.

10.2 Electrical connection



WARNING Electric shock

Realise all electrical connection and installation work in accordance with national and regional regulations.



WARNING Electric shock

If the appliance is permanently connected, it must be possible to disconnect all poles from the mains connection for an isolating distance of at least 3 mm. (RCD - residual current device)



WARNING Electric shock

Ensure that the appliance is connected to the protective earth conductor.



Damage

Observe the rating plate. The specified voltage must match the mains voltage.



► The power supply is connected directly to the appliance or, optionally, via an electrical connection cable with a mains plug.



Note

▶ Ensure that the length of the mains connection cable is sufficient to be routed correctly through the wall mounting to the connection terminal.


10.3 Commissioning

Commissioning:

- Approaching the hair dryer (the underside of the hood) to a distance of between 10–15 cm activates it without the need to touch it, and the time relay automatically deactivates it after 2.5 minutes. If you are still standing under the hair dryer after the 2.5 minutes have elapsed, it will run for another 2.5 minutes and only switch off automatically when the time has elapsed.
- Children must not play with the hair dryer.
- No objects may be inserted into the intake slot or air outlet.
- The side intake slots and the air outlet must not be covered.
- Fire hazard: No flammable cleaning agents may be used.

10.4 Activating/deactivating appliance functions

Setting the time and sensitivity





Detach the circuit print control cover

Time setting potentiometer Turn clockwise, maximum (5 min.) Turn anti-clockwise, minimum (30 sec.)






▶ Switch on the desired functions with the potentiometer according to your requirements.

10.5 Fitting the housing hood



Fit the circuit print control cover and screw tightly.





- ▶ Switch on the power supply or insert the mains plug of the electrical connection cable (if available) into the earthed
- ▶ Attention: The internal starting capacitor takes approx. 10 seconds to charge; only then does the hair dryer activate.

10.6 Handover of the appliance



- ▶ Explain the functions of the appliance and maintenance to the user.
- ▶ Ensure that the user pays particular attention to the safety instructions.
- ▶ Provide the user with these operating and installation instructions.

Cleaning and maintenance 11



WARNING Electric shock

Disconnect all poles of the appliance from the mains connection before carrying out any work.

Cleaning

Cleaning and care:

It should be noted that the appliance must be thoroughly cleaned at least 4 times a year by a specialist. This is the only way to ensure proper and safe operation.

This maintenance must be realised by an authorised specialist.

Procedure for motor, heating and control: The power supply must be disconnected!

Check automatic deactivation by operating the hair dryer. If the dryer is no longer running, use a screwdriver to loosen the upper housing screw, holding the plastic hood simultaneously with one hand, and fold down the plastic hood.

Important: The connection to the mains must be disconnected by pulling out the internal safety plug. The entire appliance is then de-energised. Only now may the lower outlet grille and the print control cover be removed. Risk of electric shock! Remove the motor protection grille, dusting out the fan louvres with a round brush and vacuum cleaner. Turn the fan blades until the dust falls out. Finished. Remove the heating element and carefully clean it to remove dust and fluff. Please ensure that the overheating protection thermostat is not damaged, otherwise the appliance will stop running for safety reasons.

Procedure for height adjuster and spiral cable: The power supply must be disconnected!

Use a screwdriver to loosen the two covers on the left and right and the two covers at the top and bottom of the height adjuster. Thoroughly remove the old lubricating grease from the precision rails with a cloth and replace it.

The black H05BQ-F spiral cable installed in the height adjuster must be checked annually for defects!

Recommission in reverse order. Test run. - Operational handover.



The manufacturer or a specialised company must be consulted in the event of any damage to the appliance (e.g. heating element, connection cable)!

- A defective mains cable may only be replaced by authorised specialist personnel.
- No objects may be inserted into the air intake slot or the air outlet.
- The side intake slots and the air outlet must not be covered.
- Opening the appliance: Disconnect the power supply, then disconnect the internal safety plug from the appliance. Only then should the air outlet grille or print control cover be removed. Risk of electric shock!
- No flammable cleaning agents may be used.

13.1 Transport and packaging material

Customer service and warranty

15 Warranty

15.1 Warranty declaration and conditions

These warranty conditions regulate additional warranty services we provide for the end customer. They are an addition to the end customer's statutory warranty claims. Statutory warranty claims against the end customer's other contractual partners are not affected by our warranty. Exercising of these statutory warranty rights is free of charge. These rights are not restricted by our warranty.

These warranty conditions only apply to appliances that are purchased by the end customer as new appliances. A warranty agreement shall not be concluded if the end customer purchases a used appliance or a new appliance from another end customer.

Spare parts are guaranteed to be available for 20 years.

15.2 Content and scope of the warranty

The warranty service is provided if a manufacturing and/or material defect occurs on our appliances within the warranty period. However, the warranty does not cover any services for appliances on which faults, damage or defects occur due to calcification; chemical or electrochemical effects; incorrect set-up or installation; improper setting, adjustment, use or operation. Also excluded are services due to inadequate or omitted maintenance, weather influences or other natural phenomena.

The warranty is void if the appliance has been repaired, tampered with or modified by persons not authorised by us.

Free access to the appliance must be ensured by the end customer. As long as there is insufficient accessibility (compliance with the minimum distances according to the operating and installation instructions) to the appliance, we are not obliged to provide the warranty service. Any additional costs caused by the location of the appliance or poor accessibility to the appliance are not covered by the warranty.

We will not accept carriage forward appliances sent to us unless we have expressly agreed to the carriage forward shipment. The warranty service includes checking whether a warranty claim exists. In the event of a warranty claim, we alone decide how the fault is to be rectified. We are entitled to have the appliance repaired or to realise the repair ourselves. Any replaced parts shall become our property.

Insofar as the customer has received services due to the warranty case on the basis of statutory warranty claims against other contractual partners, we shall have no obligation to perform.

Insofar as a warranty service is provided, we accept no liability for damage to an appliance due to theft, fire, force majeure or similar causes.

In addition to the warranty services promised above, the end customer cannot assert any claims under this warranty for indirect damage or consequential damage caused by the appliance, in particular for compensation for damage occurring outside the appliance. Legal claims of the customer against us or against third parties remain unaffected. These rights are not restricted by our warranty. The exercising of such statutory rights is free of charge.

Warranty period

The warranty period is 24 months for appliances used in private households or commercially.

The warranty period for each appliance begins when the appliance is handed over to the customer who uses the appliance for the first time

Warranty services do not lead to an extension of the warranty period. The warranty service provided does not initiate a new warranty period. This applies to all warranty services rendered, in particular for any spare parts installed or the replacement delivery of a new appliance.

Claims made under the warranty

Warranty claims must be submitted to us before the warranty period expires and within two weeks of the defect being identified. Details of the fault, the appliance and the time of detection must be provided. The invoice or other dated proof of purchase must be enclosed as proof of warranty. A warranty claim can not be asserted if the aforementioned information or documents

are missing.

Warranty for used appliances

We are not obliged to provide warranty services outside Switzerland. If an appliance used abroad malfunctions, it must be sent to customer service in Switzerland at the customer's risk and expense. The return shipment is also at the risk and expense of the customer. Any statutory claims of the customer against us or against third parties shall also remain unaffected in this case. Such statutory rights are not restricted by our warranty. The exercising of these statutory rights is free of charge.

Product liability

We are not liable for any damage or operating accidents caused by improper electrical connection, negligent maintenance, vandalism or transport damage.

Concluding remark

If it is necessary to intervene in the appliance for maintenance purposes or due to a fault, please read these operating instructions carefully. If you are unsure, consult the manufacturer or a specialised company.

Transport damage

Check the contents of the consignment. Complain about any transport damage immediately upon receipt of the goods at the responsible post office or railway station, or to the forwarding agent.

Warranty: 2 years from date of invoice

The serial number of the appliance replaces the warranty certificate. Repairs due to incorrect connection, use of force or faulty operation are not covered by the warranty.


